- **1-** Strengthen your understanding of your rights, and the quality of services you should expect to receive.
- **2-** Improve your knowledge of how to raise concerns and provide feedback with your NDIS provider.
- **3-** Work with NDIS providers to ensure they meet their responsibilities and strengthen their feedback and complaints pathways and promote participants rights by using the resources developed in this project.
